**THE SHOOLINI UNIVERSITY OF BIOTECHNOLOGY AND MANAGEMENT
SCIENCES (ESTABLISHMENT AND REGULATION) AMENDMENT ACT, 2013**

(AS ASSENTED TO BY THE GOVERNOR ON 24TH MAY, 2013)

AN

ACT

Further to amend the Shoolini University of Biotechnology and Management Sciences (Establishment and Regulation) Act, 2009 (Act No. 20 of 2009).

Be it enacted by the Legislative Assembly of Himachal Pradesh in the Sixty-fourth Year of the Republic of India as follows:—

1. **Short title and commencement.**—(1) This Act may be called the Shoolini University of Biotechnology and Management Sciences (Establishment and Regulation) Amendment Act, 2013.

(2) It shall be deemed to have come into force on 16th day of October, 2009.

2. **Amendment of section 41.**—In section 41 of the Shoolini University of Biotechnology and Management Sciences (Establishment and Regulation) Act, 2009, (20 of 2009) in sub-section (2), in the proviso, for the words "twenty five years", the words "fifty years" shall be substituted.
