Approval of the minutes of the previous meeting

Ms. Varsha Patil (Coordinator IQAC) placed the minutes of the previous meeting held on April 9, 2018 before the committee. The committee considered and confirmed the same.

Following items were further discussed as per agenda:

New courses/programs for the Academic Year 2018-19

Dr. Sunil Puri informed the committee about the new courses starting from the academic year 2018 - 19. It was recommended by the committee to have specialized faculty of agriculture for BSc Honors in agriculture and also for MSc Yoga. It was further decided by the committee that Dr. Vinod Kumar shall take charge of all the yoga courses to be offered.

The committee further felt and recommended that Faculty of Agriculture shall be created separately and School of bioengineering could be kept under the same.

MOOC Courses to be introduced

Looking after the great success of MOOC courses throughout the world committee proposed introduction of MOOC from the academic year 2018 -19. Prof Narinder Verma – Associate Dean Academic affairs informed the members that these courses provide a great opportunity to students for thinking out of box & expand their learning curve with additional knowledge. Latest research demonstrates that among learners who complete courses, MOOCs do have a real impact: 72% of survey respondents reported career benefits & 61% reported educational benefits.
